### **JOB PURPOSE**

The Yard is an award-winning charity that runs adventure play services for children with disabilities and/or additional support needs and their families. We offer creative and inclusive adventure play experiences alongside wraparound support for the whole family. We believe in fostering communities of friendship and peer support without judgement. Since we opened in 1986, our services have grown significantly, but we will always retain our holistic approach and ethos of child-centred and child-led play services.

The purpose of this post is to plan and deliver play sessions at The Yard. The applicant will be expected to deliver, with other members of the Play Team, a range of inclusive, social, recreational and adventure play activities both on The Yard's premises including a range of activities such as arts and crafts, loose parts play, water and sensory play etc. Where appropriate you will engage with parents, carers and other supporting adults of children ensuring that the whole family feels valued and part of an inclusive community.

### **KEY RESPONSIBILITIES**

- Play an active role in the set-up, delivery and development of recreational activities, in line with the organisation's values, aims and policies
- Engage children in creative play and the management of suitable activities for the different ages and interests of children
- Encourage and enable children and young people with a range of disabilities to play and socialise in an inclusive way that supports the development of their emotional wellbeing
- Always ensure the safety of the children and young people within the centre. This includes undertaking risk assessments, fire drills, having an awareness of allergies and other medical conditions and the maintenance of hygiene in food preparation
- Work with children and young people as individuals and as part of a group, within The Yard's premises
- To develop and maintain professional relationships with parents, carers and other organisations, ensuring there is always adequate communication with parents and carers to understand and appreciate the child's needs
- To contribute data to our database systems in order to support our work and support our children and families
- To provide ongoing support to sessional staff in achieving their personal development goals in accordance with the Yard's formal review procedure
- To contribute to reflective diary sessions and operate as a reflective practitioner
