JOB PURPOSE

Running for almost 40 years, The Yard is an award-winning charity that aims to build a community of support for disabled children and young people through adventure play, creating opportunities for fun and friendship and wrap around support for the whole family.

Coming to The Yard provides a sense of belonging - children have fun and parents have a space free from judgement, where everyone they meet comes from a place of kindness and understanding. One real strength of our service is that we work with disabled children from birth to twenty-five, so families are on one journey. Having that consistency of support is invaluable to families.

Our parents often refer to The Yard as a home from home. For many it is one of the only places where they can relax as a family and be themselves. As a result, families feel less isolated as they have a chance to meet others facing similar challenges and build up crucial support networks. One parent summed up the difference the service made to their family: *"I love The Yard because the smile it puts on my son's face is priceless. It's helped him grow as a person, become more open to allowing others into his space, and makes him feel safe and accepted. The staff and volunteers are amazing with all the children."*

Your role will be to help generate the income required to help us continue our amazing services, keep our existing supporters up to date and inspire new supporters to come on board. You will do so by leading and driving our corporate fundraising across our four sites in Edinburgh, Dundee, Glasgow and Fife.

It is an exciting time to join The Yard following the opening of our fourth site in Glasgow and the forthcoming launch of our purpose-built facility in Dundee following an extensive renovation. Both provide great opportunities to build our existing corporate partnerships and establish new strategic relationships moving forward.

KEY RESPONSIBILITIES

- To implement and deliver the corporate fundraising strategy and annual plans to secure ongoing support for our services across Scotland. Current Corporate target is £250,000.
- Work across this income stream to build awareness of our work and raise the profile of The Yard amongst companies across Scotland.

- Work with the Head of Fundraising to identify and initiate new corporate partnerships with businesses across Scotland and beyond.
- Research and identify new potential corporate partnerships, undertaking due diligence to ensure they align with The Yard values.
- Support with the engagement and acquisition of new strategic partners and building relationships with key decision makers.
- Develop and deliver presentations to potential new partners.
- To develop new corporate engagement opportunities to inspire new and existing partnerships.
- Review our existing charity of the year proposition and sponsorship opportunities for events and tailor accordingly.
- To represent The Yard on business networks to raise our profile and create opportunities to apply for corporate fundraising opportunities such as COTY partnerships and engage staff teams to participate in challenge events on our behalf.
- Maximise all networking opportunities to build new relationships.

Relationship Management

- Develop and deliver a relationship management approach that can be tailored to support our existing corporate partnerships and all new partnerships moving forward.
- Ensure that this new approach provides the support required to maintain and grow partnerships and maximise income generation.
- Ensure excellent levels of partnership management and stewardship.
- Undertake speaking engagements and opportunities to raise awareness and funds for The Yard.
- Work closely with the Communications Team to develop campaigns and collateral to support partnership activity.
- Working alongside Communications colleagues ensure that joint media initiatives with partners are managed and promoted
- Work with the Fundraising Assistant and support the work with small corporate supporters and activity.

Corporate Foundations

• Lead on a programme of applications to Corporate Foundations to ensure that we articulate

effectively why they should support The Yard and ensure that all applications are submitted to meet timelines and criteria. The Fundraising Assistant will also support this remit.
